Reference: Kennel Club Field Trial Regulations

DEFINITION OF STAKES

J3.d(1) OPEN STAKES: A stake in which dogs have the opportunity of gaining a qualification towards the title of Field Trial Champion(K Reg. refers) and towards entry in the Championship; in which entry is open to all dogs of a specified breed. It may be limited to a prescribed number of runners (J4 refers); in which case these shall be decided by a draw conducted in accordance with Regulation J7i. so that preference is given to previous performance

J7.i PREFERENCE IN DRAW FOR OPEN STAKES FOR RETRIEVERS A First, Second, Third or Fourth in a 24 dog Open Stake.

First, Second or Third in a 12 dog Open Stake.

First in All Aged or Novice Stakes.

Order of the Draw:

- (a) Members' dogs which have gained awards as shown above.
- (b) Non-Members' dogs which have gained awards as shown above
- (c) Members' dogs which have gained other awards (d) Non-Members' dogs which have gained other awards
- (e) Other dogs.

J3.d(2) ALL AGED: A Stake which is open to all dogs of a specified breed or breeds without restriction as to their age, but which may be restricted by any other conditions which may be determined by the Club, subject to the approval of the General Committee of the Kennel Club.

J3.d.(3) NOVICE: A Stake which is confined to dogs which have not gained a place which would qualify them for preference in the draw for Open Stakes, that is, First, Second or Third in Open Stakes or First or two Seconds in All Aged, Novice

or Puppy Stakes prior to the close of entries.

REGULATIONS AND CONDITIONS

- 1. Dogs entered at Kennel Club Licensed Field Trials must be registered at the Kennel Club in accordance with Kennel Club Regulations for Classification and Registration B.
- 2. The Club may reserve to itself the right to refuse any entry, except it shall not apply in terms of the Preference in the Draw Regulations (Ref.J.7i) The Kennel Club must be informed in writing of all such refusals, with the Club's reasons.
- 3. Should a dog be drawn to run in a stake and then be withdrawn for any reason, a substitute dog may be accepted, in consultation with the FT Secretary, to run in its place provided the substitute dog has gained an equivalent qualification for preference in the Draw and is eligible for that stake.
- 4. All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
- 5. If entries or nominations exceed the number of permitted runners, the right to compete in a Trial shall be decided by ballot.
- 6. Should circumstances so dictate the Society, in consultation with the judges, may alter arrangements as necessary. Such changes and the circumstances surrounding them will be reported to the Kennel Club.
- 7. No modification may be made to the schedule after publication except by permission of the Kennel Club, followed by advertisement in appropriate journals if time permits before the closing of entries.
- 8. Judges at a Trial are prohibited from entering a dog which is recorded in their ownership or part ownership.
- 9. DOĞS IN CARS ON HOT DAYS; Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog. If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.
- 10. Welfare of Dogs; An exhibitor (or competitor) whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not knowingly put their dogs' health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the General Committee for disciplinary action under Kennel Club Rules and Regulations.
- 11. Preference in the Draw will not be given to members who have been offered a run by the Club, in a similar Stake, in the current season.
- 12. If a dog, including a reserve dog which has been offered a run, is withdrawn within seven days before the date of the trial, the entry fee will not be refunded, unless good reason is given for the withdrawal, e.g. veterinary.
- 13. More that one nomination can be applied for but second applications will not be balloted until first applications have been
 - balloted. Names should be entered in order of choice. Any owner successful in the Draw, whether they run their dogs or not, will not be eligible for entry into any subsequent Draw for the same type of stake unless the subsequent Draw is under-subscribed or a veterinary certificate is produced.
- 14. Bitches in season must not be brought to the ground.
- 15. All persons attending the Trials must consider themselves to be under the jurisdiction of the Judges, Stewards and Officers of the Club. Competitors are reminded that for our hosts, Trials are social occasions and that Members of the Club are their guests, and should dress and conduct themselves accordingly throughout all Trials. All spectators MUST report to the Field Trial Secretary upon arrival at the Trial.
- 16. TROPHIES; All trophies are to be engraved at the winner's expense, held until required and returned in good condition for the following seasons Stake. No trophies may be taken out of the United Kingdom.
- 17. If an owner is unable to take up a run, the FT Secretary must be notified immediately by telephone, even if they are on the reserve list.
- 18. The Association cannot accept liability for any claim arising from or relating to the running of the trials.
- 19. Videography and photography will only be permitted with the express permission of the chief steward and the host.
- 20. The WELRC holds all entrants responsible for contacting us, **before the Trial takes place**, if they have not received the draw. Otherwise, if they have been drawn and do not turn up for the Trial, the Entrant, will still be charged the full entry fee.

NOTE TO NOVICE HANDLERS We are very grateful to our Hosts for their generosity in giving ground for our Trials. It is essential therefore that all competitors and their dogs must have had practical experience in the shooting field, that their dogs will pick fur and feather, warm and live game, be quiet and steady and have a soft mouth
